

# All Saints School 2026-2027 Financial Requirements

## Yearly Tuition Rates per Student

**True Cost** \$14,735      **Subsidized K-8** \$11,217.67      **PreK** \$11,217.67      **Parish Subsidized** \$9,886.67

The true cost of educating one child at All Saints School is \$14,735. Includes the \$11,217.67 subsidized tuition and a **tax-deductible donation of \$3,517.33 or \$4,848.33** for families who qualify for the Parish Subsidized Tuition. **SCRIP and Service Hours requirements are waived.**

## Registration Fee

Registration Fee for the 2026-2027 school year is **\$450.00 PER STUDENT**. The registration fee is paid at the time of registration and is non-refundable (unless your child is put on a wait list). This fee is in addition to tuition.

## Tuition Rates & Payment Options

The yearly tuition rates are established by the School Advisory Council and are based on the budgetary requirements of the school. To qualify for the Parish Subsidized tuition families must actively participate in the sacramental life of the church and regularly tithe for a minimum of \$650 by April 30, 2027. For Non-All Saints parishioners, a completed Out-of-Parish Subsidy Form is required. There are three options for tuition payments. VISA/MasterCard payment is available with an additional 4% service charge.

1. 1 Payment in full via ACH or check on July 10, 2026. This option receives a 2% discount on the yearly tuition.
2. 2 Payments via ACH or check on July 10, 2026; other half payment on January 10, 2026.
3. 12 Monthly payments via ACH on the 10th of each month beginning July 10, 2026. *All monthly payments are rounded up to the nearest dollar.*

## Tuition Assistance

Tuition assistance is available for all families. To apply for financial assistance families must complete the **FACTS Tuition Assistance Forms** ([online.factsmgt.com/signin/3GK70](https://online.factsmgt.com/signin/3GK70)) **by February 27<sup>th</sup>, 2026**. In addition to receiving assistance from All Saints, Catholic families, including those affiliated with another parish, may qualify for Archdiocesan financial aid grants through FACTS.

## Parish Subsidies

The Parish Subsidy helps All Saints School bridge the gap between the Parish Subsidized tuition rate and the true cost to educate a student. Students from other Catholic parishes may receive a subsidy by returning a signed Out of Parish Subsidy Form from their pastor to All Saints.

## Other Obligations of Enrollment

***Please note that each of these obligations carry a monetary charge should families not meet them during the school year.***

-All Saints School asks that each family contribute **30 service hours** over the course of the year. Each family is responsible for logging their hours in FACTS by May 17<sup>th</sup>, 2027. We ask that you give 10 hours of service to All Saints Parish and 20 hours of service to the school. For families with a single custodial parent, **15 service hours** are needed (5 hours to All Saints Parish and 10 to school). You may choose to buyout your service hours at \$30.00/hour.

-Families are required to purchase **\$2,000.00 in SCRIP** (by May 15, 2027) **or** buyout at \$200.00.

-4<sup>th</sup> grade Technology Fee is \$50.00 for loaned Chromebook, licensing and infrastructure.

-5<sup>th</sup>-8<sup>th</sup> grade Technology Fee is \$150.00 annually for Chromebook, licensing, and infrastructure. The device will belong to student upon graduation.

**In the event there are more candidates for a grade than there are openings, the following list of priorities are used in the selection of new students:**

- Currently enrolled students in good standing are assured a place for the coming year.
- Children of Catholic families of All Saints Parish who have other siblings currently enrolled in All Saints School.
- Children of Catholic families of All Saints Parish who have no siblings enrolled in All Saints School.
- Children of parishioners of other Catholic parishes without a school or with a school that is over-enrolled who have other siblings currently enrolled in All Saints School.
- Children of non-Catholic families with other siblings currently enrolled in All Saints School. Children of
- All Saints staff who do not qualify under any of the above.
- Children of parishioners of other Catholic parishes without a school or with a school that is over-enrolled who have no siblings enrolled in All Saints School.
- Children of Catholic families who are not All Saints parishioners.
- Children whose parents support the philosophy of Catholic education.
